BY-LAW NUMBER 2012- 3


**A BY-LAW TO AMEND BY-LAW 2006-193, BEING A BY-LAW TO ESTABLISH AND REGULATE FEES AND CHARGES FOR VARIOUS SERVICES OR ACTIVITIES AND USE OF PROPERTY AS PROVIDED BY THE MUNICIPALITY; AND TO REPEAL BY-LAW 2011-135**


WHEREAS Council deems it necessary and advisable to amend By-law 2006-193, known as the "Fees and Charges By-law", enacted by Council on December 12<sup>th</sup>, 2006, and amend from time to time, to include membership rates and facility rental charges for the Welland Community Wellness Complex and facility rental rates for the recently renovated Welland Arena;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF WELLAND ENACTS AS FOLLOWS:

1. That By-law 2006-193 shall be and the same is hereby amended by replacing the existing Schedule "A" with Schedule "A" attached hereto and for all purposes forming a part of this by-law.
2. That By-law Number 2011-135 shall be and the same are hereby repealed.
3. The fees and charges affected by the by-law shall come into force and take effect upon the date of passage, unless otherwise specified on Schedule "A".
