The City of Welland purchases its water from the Regional Municipality of Niagara. Water supplied to the water distribution system in the City of Welland, is treated at the Welland Water Treatment Plant, located at 4 Cross Street. The source of water for this plant is 'surface water' from Lake Erie, via the Welland Canal and the Welland Recreational Waterway (Old Welland canal). The Welland Water Treatment Plant is a conventional water treatment plant which incorporates zebra mussel control, traveling screens, coagulation, flocculation, sedimentation, filtration, and disinfection in its process with the ability to go to direct filtration when raw water conditions permit. The Welland Water treatment plant provides water to the City of Welland, Town of Pelham, and part of the City of Thorold as well as The Highlands Residents Association Private Development off of Daimler Parkway. Treated water from the Welland Water Treatment Plant is distributed to Welland residents through approximately 270kilometers of City, and 30.5 kilometers of Regional water main, which range in size from 50mm (2 inch) to 750mm (30inch).
