Please read this information before submitting your application for a Residential Parking Permit

- Residential Parking Permit is only valid for the location listed on the front of the permit.
- First permit registered at designated address is provided at no cost. Additional permits are \$25.00 + H.S.T.
- Proof of residency and proof that all vehicles are registered to their address is required at the time of application. All documents must contain your name and correct address. If neither shows your correct address, you must present a lease agreement, current utility bill or purchase/ sale agreement prior to the permit being issued.
- Permits are valid for 1 year from date of purchase.
- Permit holders must continue to obey all general parking by-laws:
 - Vehicles cannot park within 10m of an intersection
 - Vehicles cannot park within 1.5m of a driveway
 - Vehicles cannot park longer than 12 hours on any highway
 - Vehicles cannot park within 3m of a fire hydrant
 - Vehicles cannot obstruct snow clearing operations(for a full list of parking violations please review the Traffic & Parking By-law 89-2000)
- Permit shall be affixed to the rear view mirror or placed on the drivers side dashboard.
- All permit applications are subject to review and approval by City Staff.
- A Residential Parking Permit does not guarantee a parking space.
- The City reserves the right to cancel a permit at any time for improper use of the permit.
