THE CORPORATION OF THE CITY OF WELLAND

BY-LAW NUMBER 1999 - 94

**A BY-LAW TO AMEND BY-LAW 3211 (BEING A BY-LAW TO ESTABLISH A DEPARTMENT OF INDUSTRIES TO BE KNOWN AS THE WELLAND INDUSTRIAL COMMISSION) NOW KNOWN AS THE WELLAND DEVELOPMENT COMMISSION, AND TO REPEAL BY-LAWS 9808 AND 1999-73**

WHEREAS Council has determined that the Welland Development Commission and the Economic Development Committee should be amalgamated under the name of the "Welland Development Commission", with further restructuring to enlarge the Board of Directors of the said Commission from 11 to 15 Directors;

AND WHEREAS Council further deems it necessary and advisable to establish a formula for the appointment of such directors, including the appointment of 4 directors to fill the vacancies created by the enlargement of the Board;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF WELLAND ENACTS AS FOLLOWS:

1. By-law 3211 shall be and the same is hereby amended by the amalgamation of the Welland Development Commission with the Economic Development Committee of Council under the name of the "Welland Development Commission".
2. The Board of Directors of the Welland Development Commission, shall consist of fifteen (15) Directors, appointed by Council as follows:
  - (a) five (5) directors shall be members of City Council;
  - (b) two (2) directors shall be members of the Greater Welland Chamber of Commerce;
  - (c) three (3) members who shall not be members of the City Council;
  - (d) two (2) members recommended by the Greater Welland Chamber of Commerce who are not necessarily members of the Chamber;
  - (e) one (1) member who shall be an elected member of the City of Welland on the Council of the Regional Municipality of Niagara; and
  - (f) the Mayor and Chief Administrative Officer of the City of Welland shall be ex-officio members.


4. The term of all of the appointed Directors shall be concurrent with and expire with the term of Council.

5. That By-laws 9808 and 1999-73 be and the same are hereby repealed.

6. This By-law shall come into force and take effect upon the day of its passage.
