Please be advised the Council of The Corporation of the Town of Niagara-on-the Lake, at its regular meeting held on September 23, 2025, approved the following resolution:

WHEREAS democracy is healthy when everyone is able to participate fully and safely and contribute to the well-being of their community;

WHEREAS we are witnessing the dissolution of democratic discourse and respectful debate across all levels of government and in neighbouring jurisdictions;

WHEREAS Ontario's municipally elected officials are dealing with increasingly hostile, unsafe work environments facing threats and harassment;

WHEREAS social medial platforms have exacerbated disrespectful dialogue, negative commentary, and toxic engagement which disincentivizes individuals, especially women and candidates from diverse backgrounds from running for office;

WHEREAS better decisions are made when democracy is respectful and constructive and the voices of diverse genders, identities, ethnicities, races, sexual orientation, ages and abilities are heard and represented around municipal council tables;

WHEREAS the Association of Municipalities of Ontario's Healthy Democracy Project has identified concerning trends with fewer people voting in local elections and running for municipal office;

THEREFORE BE IT RESOLVED that the Town of Niagara-on-the-Lake Council supports the Elect Respect pledge and commits to:

- Treat others with respect in all spaces—public, private, and online,
- Reject and call out harassment, abuse, and personal attacks,
- Focus debate on ideas and policies, not personal attacks,
- Help build a supportive culture where people of all backgrounds feel safe to run for and hold office,
- Call on relevant authorities to ensure the protection of elected officials who face abuse or threats, and
- Model integrity and respect by holding one another to the highest standards of conduct; and

BE IT FURTHER RESOLVED that the Town of Niagara-on-the-Lake Council calls on elected officials, organizations and community members to support the Elect Respect campaign and sign the online pledge at www.electrespect.ca; and

BE IT FURTHER RESOLVED that a copy of this resolution be sent to the Association of Municipalities of Ontario, Ontario's Big City Mayors, the Federation of Canadian Municipalities, Mayors and Regional Chairs of Ontario, relevant MPs and MPPs, Regional Police, the Ontario Provincial Police and the Royal Canadian Mounted Police.

RE: Endorse the Development of a Code of Conduct for Human Trafficking Prevention in Niagara Region

Please be advised the Council of The Corporation of the Town of Niagara-on-the Lake, at its regular meeting held on September 23, 2025, approved the following resolution:

WHEREAS human trafficking in Niagara is currently a persistent challenge impacting the hospitality and tourism sectors;

WHEREAS human trafficking is a critical issue due to the region's proximity to the U.S. border and the thriving tourism and hospitality sectors, which create environments where sexual and labour exploitation can go unnoticed;

WHEREAS women, newcomers, racially-marginalized people, people experiencing poverty, people living with disabilities, and children in the child welfare system are disproportionately targeted and impacted by the harms perpetuated by traffickers;

WHEREAS 60% of human trafficking cases in Ontario occur along the corridor linking Toronto and Niagara;

WHEREAS data from the Niagara Regional Police Service comparing 2023 to 2024 indicates the number of human trafficking investigations increased by 61%; the number of victims identified increased by 700%; the number of accused charged increased by 190%; the number of criminal charges laid increased by 75%; and the number of referrals from NRPS' Human Trafficking Unit to Victim Services Niagara increased by 133%;

WHEREAS human trafficking thrives in secrecy, but with leadership and commitment, local government can be on the front line of prevention and protection he Association of Municipalities of Ontario's Healthy Democracy Project has identified concerning trends with fewer people voting in local elections and running for municipal office;

WHEREAS local businesses and organizations are key to preventing human trafficking through proactive measures such as The 4 Ps: prevention, protection, partnership, and prosecution;

WHEREAS local area municipalities have already begun to assist in making the Niagara region inhospitable to human traffickers;

WHEREAS Tools of Empowerment for Success (TOES) Niagara and Brock University have undertaken work funded by Women and Gender Equality Canada to develop a Code of Conduct to Prevent Human Trafficking in the Niagara Region through education, increasing awareness, and providing resources, including prevention strategies; and

WHEREAS TOES Niagara and Brock University created a Steering Committee of representatives from across tourism, business, education, law enforcement, government, and non-profit sectors to engage in broad community collaboration through focus groups, surveys, and feedback sessions to develop the Code of Conduct for Human Trafficking Prevention in the Niagara Region.

THEREFORE BE IT RESOLVED that the Town of Niagara-on-the-Lake recognize that human trafficking in Niagara has serious impacts on the health and wellness of local residents and their families, as well as negative economic impacts on local businesses and communities; and

BE IT FURTHER RESOLVED that the Town of Niagara-on-the-Lake endorse the work of TOES Niagara and Brock University in developing a Code of Conduct for the Prevention of Human Trafficking in the Niagara Region; and

BE IT FURTHER RESOLVED that the Town of Niagara-on-the-Lake COMMIT to reviewing and assessing the applicable local government sectoral guidelines and responsibilities outlined in The Code upon its finalization, with the intent to implement measures that align with Regional priorities and capacity; and

BE IT FURTHER RESOLVED that the Town of Niagara-on-the-Lake write letters to all Niagara's 12 Local Area Municipalities encouraging them to also endorse the work of TOES Niagara and Brock University in the development of the Code of Conduct for the Prevention of Human Trafficking in the Niagara Region and commit to reviewing and assessing the applicable local government sectoral guidelines and responsibilities outlined in The Code upon its finalization, with the intent to implement measures that align with municipal priorities and capacity; and

BE IT FURTHER RESOLVED that a copy of this motion BE SENT to Niagara's four MPs; Niagara's four MPPs; the Association of Municipalities of Ontario (AMO); the Federation of Canadian Municipalities (FCM); Mayors and Regional Chairs of Ontario (MARCO); Ontario's Big City Mayors (OBCM); and the Ontario and Canadian Associations of Chiefs of Police.

Economic Development Brief

Statistics and Trends

Labour market conditions

Seasonally adjusted labour market conditions in Niagara did not improve across most indicators in September, with the exception of population growth. While Ontario and Canada performed slightly better, both still experienced employment losses.

Month-over-month data from August to September 2025 show the following:

- Population: Niagara grew by 0.1% (300 people), while Ontario grew by the same rate.
- Labour force: Niagara decreased by 1.5% (3,800 people), while Ontario decreased by 0.04%.
- Employment: Niagara decreased by 1.6% (3,800 people), while Ontario decreased by 0.1%
- Unemployment rate: Niagara increased by 0.1% to 7.1%, while Ontario remained at 7.8%.
- Participation rate: Niagara decreased by 1.0% to 59.6%, while Ontario remained the same at 64.0%.

While previous recent employment losses were mostly concentrated in trade-oriented sectors such as manufacturing, this was not the case in Niagara in September. The sectors with the highest rates of employment decline included information, culture, and recreation; finance, insurance, and real estate; transportation and warehousing; wholesale and retail trade; and public administration, which is a change from pervious months. In contrast, manufacturing employment rebounded by 2.9% in September.

Canada's economy slowing as major trade renegotiation looms

Canada's economy is slowing alongside global trends with growth expected to reach only 1.2% this year and remain subdued through 2026 amid trade uncertainties. Although inflation has eased to the Bank of Canada's 2% target, essential goods like food and services continue to see elevated prices that strain lower income households. The Bank of Canada has room to further ease monetary policy and markets expect at least one more interest rate cut in October or December. Despite headline inflation averaging 1.9% consumers still perceive high inflation due to persistently expensive essentials influencing household spending behaviour.

Economic Development Updates

International Plowing Match in Niagara deemed a success

The 106th International Plowing Match and Rural Expo from September 16-20 in West Lincoln drew nearly 70,000 visitors over five days, including Ontario political leaders, and was hailed as a major success by organizers. The event featured agricultural showcases, local attractions, and community initiatives that raised over \$4,200 and collected food donations for West Lincoln Community Care. It also highlighted local pride, with West Lincoln winning a beautification award and generating significant regional economic activity, estimated at around \$25 million for west Niagara.

Venture Niagara increases Express Loan limit to \$35,000

Venture Niagara Community Futures Development Corporation has increased its Express Loan program limit from \$20,000 to \$35,000. The program, available as a term loan or operating line, is designed to provide fast and flexible financing for businesses in Niagara. By raising the limit, Venture Niagara is ensuring that local businesses have greater access to capital when they need it.

St. Catharines launches downtown forgivable loan program to boost housing supply

The City of St. Catharines has launched the Downtown Forgivable Loan Program to encourage residential development in the downtown core and support inclusive, sustainable housing goals. The program offers eligible property owners interest-free, forgivable loans of up to \$150,000 per property to convert underused spaces into new or accessible housing units. Funded through the federal Housing Accelerator Fund, the DFLP is part of a broader plan to unlock over 2,300 housing units in three years and strengthen the city's housing supply.

Local tourism saw gains this summer despite a drop in US visits

Despite concerns that a trade conflict would severely hurt Niagara Falls tourism, the 2025 summer season was strong overall, according to Niagara Parks CEO David Adames. While revenue from American visitors fell by about 5%, increased travel from Canada and overseas markets such as the UK, Germany, and South Korea boosted by new flight routes and promotional campaigns more than offset the decline. Overall tourism revenue rose, supported by initiatives like the Canada Strong Pass and the successful launch of the new Niagara Takes Flight attraction, with positive momentum continuing into the fall season.

Minister Anand to host G7 Foreign Ministers Meeting in the Niagara

Foreign Affairs Minister Anita Anand has announced that the G7 Foreign Ministers Meeting will be held in Niagara from November 11 to 12, 2025. This will be Canada's second time hosting G7 foreign ministers in 2025, following the March meeting in Charlevoix, Quebec. The gathering will focus on global security, economic resilience, and strengthening international cooperation in response to shared global challenges.

SPARK initiative to position Brock as global leader in climate action

Brock University has launched SPARK (sustainability, performance, adaptation, renewal and knowledge), a three-year clean infrastructure program aimed at dramatically reducing the campus's environmental impact. The initiative will cut greenhouse gas emissions by 83% by 2028 and energy use by 60%, exceeding Brock's previous sustainability goals. Funded through a partnership with the Canada Infrastructure Bank and Enbridge Sustain, SPARK will modernize key campus facilities without upfront costs, enhancing energy efficiency, system performance, and the overall student experience.

Innovate Niagara announces i.d.e.a. Fund Cohort 4

12 Niagara-based companies have been awarded non-repayable contributions of up to \$20,000 each through Cohort Four of the i.d.e.a. Fund, delivered by Innovate Niagara in partnership with Boundless Accelerator. The fund supports southern Ontario clean growth firms in developing environmentally sustainable products and technologies that advance Canada's climate goals. Backed by a \$5.2 million federal investment through FedDev Ontario, the program promotes inclusion, diversity, and circular economy innovation across six Regional Innovation Centres. Since its launch in 2022, the i.d.e.a. Fund has supported nearly 320 businesses, strengthening the region's cleantech and innovation sectors.

Hamilton-Niagara Market Diversification Forum to be held on October 29

Niagara Economic Development, in partnership with Hamilton Economic Development, are hosting a free one-day seminar on October 29 to help local businesses access high-growth markets in Europe and the Indo-Pacific. Led by an expert from Foreign International Trade Training (FITT), the global standard for international trade training and certification, the session will provide strategic insights into key sectors, trade agreements, and cultural considerations in these regions. The seminar will guide participants through tools and examples to evaluate, compare, and select the most promising international markets for their business. To register CLICK HERE.

Niagara Grape & Wine Festival generates significant economic impact

The Niagara Grape & Wine Festival kicked off in Montebello Park, marking its 73rd year as Canada's largest and oldest wine celebration. The event attracts over 25,000 visitors annually, generating an estimated \$25 million in local economic impact and supporting hundreds of local jobs. From the Wine & Culinary Village to the Grande Parade, the festival continues to drive tourism, showcase Niagara's talent, and foster pride in our community.

City of Welland hosts regional purchasing open house to help local businesses connect. The City of Welland hosted a Purchasing Open House on September 25, bringing together procurement professionals from Niagara municipalities to strengthen local economies and promote transparent procurement practices. The event helped local businesses understand municipal purchasing processes, connect with procurement teams, and learn how to participate in bids or become a Vendor of Record. This first-of-its-kind regional initiative reflects a commitment to collaboration, inclusivity, and economic growth, while laying the groundwork for stronger future partnerships across Niagara.

Province investing \$2.4 million to expand Brock University's nursing program

Ontario is investing an additional \$2.4 million in Brock University's nursing program to train up to 60 more nurses by 2029, addressing ongoing nursing shortages across the province. The funding supports the education of nurse practitioners, registered nurses, and practical nurses, and includes \$500,000 for critical supplies and lab equipment to ensure hands-on training. This investment is part of a larger \$56.8 million provincial plan to add 2,200 nursing professionals to Ontario's workforce, helping improve access to care in hospitals, long-term care homes, and community health settings.

Weekend GO train service expanding in Niagara

Starting in November, weekend GO train service between Niagara Falls and Toronto will increase from 6 to 8 trips, offering greater flexibility for travelers. The expansion is part of broader GO Transit service growth to meet rising regional demand, while weekday service remains unchanged. Additionally, the new Confederation GO station in Stoney Creek will open on October 27, providing more convenient access for Hamilton and Niagara riders and connecting with multiple train and bus routes.

Please be advised that at its meeting held on Wednesday, September 17, 2025, the Council of The Regional Municipality of Halton unanimously adopted the following resolution:

RESOLUTION: Public Safety Requirements to Protect Our Communities

WHEREAS community safety is the foremost responsibility of all levels of government, including federal, provincial/territorial, and municipal authorities; AND WHEREAS recent violent home invasions in Halton Region and across Canada highlight the ongoing need to evaluate and strengthen bail laws and the administration of justice to better protect communities;

AND WHEREAS repeat violent offenders continue to be granted bail in some instances, placing victims, families, and first responders at risk, and public confidence in the justice system is undermined when such offenders are quickly returned to the community;

AND WHEREAS the federal government passed Bill C-48, which came into force in January 2024, introducing key reforms to the Criminal Code, including:

- A new reverse onus provision targeting repeat violent offending involving weapons,
- An expanded list of firearms offences triggering reverse onus,

 Requirements for courts to consider an accused's violent history and state on the record their consideration of community safety;

AND WHEREAS the federal government has committed to tabling additional legislation during the Fall 2025 session of Parliament to further strengthen community safety, including reforms related to bail and sentencing;

AND WHEREAS the provinces and territories are responsible for the administration of justice, including:

- Appointing justices of the peace and judges,
- Managing court operations and bail monitoring,
- · Hiring and managing Crown Attorneys,
- Funding and overseeing provincial police services and detention centres;

AND WHEREAS on November 13, 2024, the Police Association of Ontario (PAO), the Ontario Provincial Police Association (OPPA), and the Toronto Police Association (TPA), representing 35,000 police members in Ontario, called for urgent action to ensure violent and repeat offenders are not released pending trial, and similar calls have been echoed by the Canadian Association of Chiefs of Police and Canada's Premiers;

AND WHEREAS strengthening bail provisions and the broader justice system requires ongoing collaboration across all levels of government, and doing so would reduce pressures on local police services, the courts, and municipalities;

NOW THEREFORE IT BE RESOLVED:

THAT Halton Regional Council:

- Recognizes the steps already taken by the federal government through Bill C-48 and acknowledges the commitment to introduce further legislation in Fall 2025;
- 2. Calls on the Government of Canada to prioritize and expedite the introduction of its promised bail and sentencing reforms in the upcoming session of Parliament;
- 3. Calls on the Province of Ontario to invest in and strengthen the administration of justice, including:
 - Enhancing bail enforcement and monitoring,

- Increasing resources for Crown prosecutors and court operations, including the previously announced courthouse for Halton
- Expanding judicial capacity and detention infrastructure;
- 4. Encourages a national, coordinated approach involving all levels of government to ensure community safety is not compromised by gaps in bail or sentencing systems.

AND BE IT FURTHER RESOLVED:

- THAT Halton Regional Council calls for the following policy considerations in future reforms:
 - Expanding reverse onus provisions for repeat violent offenders,
 - Establishing stronger mandatory bail conditions, including firearm prohibitions, curfews, electronic monitoring, and no-contact orders,
 - Limiting multiple bail releases for individuals with histories of serious violent offences,
 - Improving inter-agency information sharing among police, Crown prosecutors, and corrections,
 - Prioritizing victim and community impact in bail decisions;
- THAT Halton Regional Council calls on the federal and provincial governments to review Criminal Code time limits and rules for stay of proceedings in cases involving serious and violent offences;
- THAT this motion be forwarded to:
 - The Prime Minister of Canada, the Minister of Justice and Attorney General of Canada, the Minister of Public Safety, the Secretary of State (Combatting Crime),
 - The Premier of Ontario, Attorney General of Ontario, the Solicitor General of Ontario,
 - All federal and provincial parties in the House of Commons and Ontario Legislature;
 - Halton's Members of Parliament and Members of Provincial Parliament,
 - The Canadian Association of Chiefs of Police, the Ontario Association of Chiefs of Police, the Police Association of Ontario, and the Ontario Provincial Police Association;
 - Ontario Association of Police Service Boards (OAPSB) and Canadian Association of Police Governance (CAPG);

- Halton's Local Municipalities;
- THAT this motion be shared with the Association of Municipalities of Ontario (AMO), the Federation of Canadian Municipalities (FCM), and all municipalities across Ontario and Canada, encouraging them to pass similar motions in a spirit of collaborative, cross-jurisdictional reform.

Dear Fire Marshal Pegg,

On behalf of the Township of Casey, we are writing to express our support for the firefighter certification requirements outlined in Ontario Regulation 343/22. We recognize the importance of standardized training and certification in enhancing firefighter safety, service quality, and public confidence across the province.

When firefighter certification was first introduced in 2018, many rural municipalities voiced concern, noting that they do not offer the same level of fire protection services as larger municipalities or urban centres. The Province graciously responded by introducing legislation to allow municipalities to certify firefighters only to the services they actually provide. This flexibility is greatly appreciated and reflects a thoughtful understanding of the diverse realities across Ontario.

However, despite this accommodation, training programs for many of these service-specific certifications are still not available or are only in "pilot" while there remains a large demand for these programs. The Province cannot reasonably expect volunteer firefighters—many of whom work full-time jobs—to independently develop training programs that meet the standards required to pass certification exams. This places an undue burden on small municipalities and risks compromising the intent of the regulation.

We have enclosed a formal resolution passed by our Council, which outlines our concerns and respectfully requests that the province extend the certification deadline to a minimum of two years beyond the final release date of the Ontario Seal programs offered in the regulation to allow time for volunteer fire departments to access these training programs and achieve certification.

AND WHEREAS the Township recognizes and supports the value of the certification requirements mandated by the Province of Ontario, acknowledging that standardized training enhances firefighter safety, service quality, and public trust;

AND WHEREAS the Office of the Fire Marshal (OFM) and Ontario Fire College (OFC) are actively working to provide training and certification programs, including offering over 600 courses annually, yet some certification programs and testing resources remain under development or are not yet widely accessible, particularly in the Ontario Seal Programs;
