Statistics and Trends

Labour market conditions

Seasonally adjusted labour market conditions in Niagara showed improvements across all indicators in December, with the exception of the unemployment rate. Labour market conditions in Ontario and Canada also showed modest improvement.

Month-over-month data from November to December 2025 show the following:

- Population: Niagara grew by 0.05% (200 people), while Ontario also grew by 0.05%.
- Labour force: Niagara increased by 0.4% (900 people), while Ontario increased by 0.3%.
- Employment: Niagara increased by 0.1% (200 people), while Ontario increased by 0.3%.
- Unemployment rate: Niagara increased by 0.3% to 6.9%, while Ontario remained the same at 7.6%.
- Participation rate: Niagara increased by 0.2% to 58.9%, while Ontario increased by 0.1% to 65%.

Although Niagara's unemployment rate increased slightly, this reflected an increase in labour force participation that outpaced employment growth during the period. Employment levels did not decline; instead, new entrants to the labour force have not yet been absorbed.

Economic Development Updates

First Niagara Greenhouse Growers AGM takes place

Niagara greenhouse operators have formed the Niagara Greenhouse Growers to address growing municipal pressures related to by-laws, development charges, and regulations. Their first AGM was in December. Chair John Bokestyn says greenhouses should not be treated like subdivisions or shopping plazas, as they receive fewer municipal services and face different operational realities. The group, which began in Lincoln and now represents most Niagara greenhouses, aims to advocate for the modern, highly automated greenhouse sector that plays a key role in the region's agricultural economy.

Seaway could double traffic with federal investment

Marine industry leaders are calling on the federal government to invest in the St. Lawrence Seaway through the \$5 billion Trade Diversification Corridors Fund, saying the system has significant unused capacity and could potentially double its traffic. They argue that extending the navigation season, improving icebreaking capacity, and investing in modern infrastructure and technology would deliver quick economic returns and strengthen trade links. The Great Lakes–St. Lawrence Seaway corridor already contributes \$66.1 billion to the economy and supports nearly 360,000 jobs, and industry leaders say greater government partnership is needed to fully unlock its potential.

Ontario government launches Destination Niagara Strategy

The Ontario government has launched the Destination Niagara Strategy, a multibillion-dollar plan to position Niagara as a world-renowned, four-season tourism destination while supporting jobs, local businesses, and economic growth. The strategy aims to attract 25 million annual visitors and double the region's tourism impact, adding an estimated \$3 billion to Ontario's GDP each year. Investments will focus on five pillars: new tourism attractions, expanded gaming, wine and culinary tourism, arts and culture, and major transportation improvements to enhance access to the region. Key projects include potential theme parks, an observation wheel, revitalized heritage sites, improved transit and air access, and expanded partnerships with Niagara Parks and the private sector. Feds announce support for Ontario's steel industry including Niagara firms

Canada's AI Minister Evan Solomon and St. Catharines MP Chris Bittle announced tariff relief funding during a visit to Kit Steel in Welland aimed at helping local manufacturers respond, adapt, and compete amid shifting market conditions. The federal government is investing \$3.4 million through the Regional Tariff Relief Initiative to support four Ontario steel companies, including Niagara-based firms Kit Steel (Welland) and Steelcon Fabrication Inc. (St. Catharines/Welland). The funding includes \$650,000 for Kit Steel and \$1 million for Steelcon Fabrication Inc. The initiative is designed to help businesses protect jobs, enhance competitiveness, and pursue new growth opportunities in Canada and abroad.

MPP Oosterhoff announces over \$31 million in manufacturing investments in Niagara

The Ontario government is supporting a \$31.98 million investment by seven Niagara-based manufacturers that will create more than 70 new good paying jobs in the region. The province is contributing \$5.3 million through the Regional Development Program's Southwestern Ontario Development Fund to help companies expand operations, boost innovation, and strengthen local supply chains. Projects recipients include Ophardt Hygiene Technologies (Lincoln), Galaxy Pallets (West Lincoln), Bradshaw Iron Works (Welland), Black Creek Metal (Thorold), CMI Heavy Industries (Fort Erie), Decora Powder Coatings (St. Catharines), and the City of Port Colborne (East Side Employment Lands).

Niagara College enhances clean energy training with provincial investment

Niagara College and the Province of Ontario are investing in advanced instructional equipment at the Welland Campus to enhance training for students in the Renewable Energies Technician program, with a total project cost of \$612,084. The upgraded facilities, including a solar training roof, heat pump trainers, and geothermal systems, provide hands-on learning to prepare graduates for careers in solar, wind, geothermal, and energy efficiency technologies. With strong provincial support and growing industry demand, the program equips students with the skills needed for high-demand clean-energy careers both in Canada and abroad.

Strengthening marine and trade partnerships: Chamber of Marine Commerce

The City of St. Catharines and the City of Welland have officially joined the Chamber of Marine Commerce reinforcing Niagara's role within the Great Lakes–St. Lawrence trade network. This partnership underscores the strategic importance of the Welland Canal as a key economic corridor connecting local industries to national and global markets. By participating in the Welland Canal Corridor initiative, St. Catharines is supporting sustainable trade, fostering regional collaboration, and ensuring local perspectives help shape the future of Canada's marine economy.

EarlyON Child and Family Centre: new location

Parents, caregivers, and their little ones will be welcomed at the new EarlyON Child and Family Centre location at the Lincoln Community Hub (formerly Beamsville District Secondary School), located at 4317 Central Avenue, Beamsville. This expanded service offering enhances access to early years programming right here in our community, supporting healthy child development and strong families.

Beamsville Early Learning and Child Care Centre expansion: Lincoln Community Hub

The Beamsville Early Learning and Child Care Centre is expanding, significantly increasing licensed childcare capacity for west Niagara families. The centre will grow from approx. 93 to 930 square metres across two floors, expanding from 39 to 113 child spaces. The expansion will add infant, toddler, and preschool classrooms, allowing care for children aged one to four years, along with expanded outdoor play areas and additional parking. Construction will begin in spring 2026 and be largely completed by year end. This project responds to strong demand, with extensive waitlists currently in place, and will create new employment opportunities for early childhood educators. The expansion also aligns with Niagara Region's childcare strategy under the Canada-Wide Early Learning and Child Care System, supported through provincial and federal funding. By increasing access to high-quality childcare, the project supports workforce participation and contributes to long-term economic growth in the Town of Lincoln.

Moyers Farm groundbreaking

Congratulations to Moyers Farm on the official groundbreaking of their new candy apple processing facility in Lincoln. The family-owned business with roots in farming dating back to 1799 is expanding operations locally, marking a major milestone in the growth of Lincoln's agri-business sector. This development showcases continued investment in Lincoln's agricultural economy, helps support local jobs, and further strengthens our rural community while reinforcing Lincoln's reputation as a leader in agri-innovation and enterprise.

St. Catharines 150: Launch of anniversary celebrations

On January 5, 2026, Mayor Mat Siscoe officially launched the City of St. Catharines' 150th anniversary celebrations with a ceremonial flag raising at City Hall. The milestone year is guided by the theme "Our Common Ground," reflecting the shared history, values, and experiences that have shaped the community since the City's incorporation on May 1, 1876. The event brought together community leaders and representatives from all levels of government, members of Council, and senior leadership. Planned initiatives throughout 2026 include a community celebration on Saturday, May 2 at Montebello Park; an enhanced Canada Day celebration on July 1, including a first-of-its-kind evening experience; the appointment of a Poet Laureate for the anniversary year; public art initiatives, including a juried City Hall exhibition, a downtown mural, and a Five Corners installation honouring indigenous history; weekly social media storytelling highlighting diverse local histories; a 150th anniversary tree planting legacy project; and pop-up activations at community events throughout the year. Additional programming and participation opportunities will be announced throughout 2026.

Please be advised that Council of the Corporation of the Town of Lincoln at its Council Meeting held on December 15, 2025, passed the following resolution:

Resolution Number: RC-2025-115

Moved by: Mayor Sandra Easton; Seconded by: Councillor Anna Murre

WHEREAS Human trafficking in Niagara is currently a persistent challenge impacting the hospitality and tourism sectors; and

WHEREAS Human trafficking is a critical issue due to the region's proximity to the U.S. border and the thriving tourism and hospitality sectors, which create environments where sexual and labour exploitation can go unnoticed; and

WHEREAS Women, newcomers, racially marginalized people, people experiencing poverty, people living with disabilities, and children in the child welfare system are disproportionately targeted and impacted by the harms perpetuated by traffickers; and

WHEREAS 60% of human trafficking cases in Ontario occur along the corridor linking Toronto and Niagara; and

WHEREAS Data from the Niagara Regional Police Service comparing 2023 to 2024 indicates the number of human trafficking investigations increased by 61%; the number of victims identified increased by 700%; the number of accused charged increased by 190%; the number of criminal charges laid increased by 75%; and the number of referrals from NRPS' Human Trafficking Unit to Victim Services Niagara increased by 133%; and

WHEREAS Human trafficking thrives in secrecy, but with leadership and commitment, local government can be on the front line of prevention and protection. The Association of Municipalities of Ontario's Healthy Democracy Project has identified concerning trends with fewer people voting in local elections and running for municipal office; and

WHEREAS Local businesses and organizations are key to preventing human trafficking through proactive measures such as the 4 Ps: prevention, protection, partnership, and prosecution; and

WHEREAS Local area municipalities have already begun to assist in making the Niagara region inhospitable to human traffickers; and

WHEREAS Tools of Empowerment for Success (TOES) Niagara and Brock University have undertaken work funded by Women and Gender Equality Canada to develop a Code of Conduct to Prevent Human Trafficking in the Niagara Region through education, increasing awareness, and providing resources, including prevention strategies; and

WHEREAS TOES Niagara and Brock University created a Steering Committee of representatives from across tourism, business, education, law enforcement, government, and non-profit sectors to engage in broad community collaboration through focus groups, surveys, and feed-back sessions to develop the Code of Conduct for Human Trafficking Prevention in the Niagara Region.

NOW THEREFORE BE IT RESOLVED THAT the Council of the Town of Lincoln:

1. Recognize that human trafficking in Niagara has serious impacts on the health and wellness of local residents and their families, as well as negative economic impacts on local businesses and communities; and
2. Endorse the work of TOES Niagara and Brock University in developing a Code of Conduct for the Prevention of Human Trafficking in the Niagara Region; and
3. Commit to reviewing and assessing the applicable local government sectoral guidelines and responsibilities outlined in The Code upon its finalization, with the intent to implement measures that align with regional priorities and capacity; and
4. Write letters to all Niagara's Local Area Municipalities and Niagara Region encouraging them to also endorse the work of TOES Niagara and Brock University in the development of the Code of Conduct for the Prevention of Human Trafficking in the Niagara Region and commit to reviewing and assessing the applicable local government sectoral guidelines and responsibilities outlined in The Code upon its finalization,

with the intent to implement measures that align with municipal priorities and capacity; and

5. Requests that a copy of this resolution be circulated to Niagara's four MPs; Niagara's four MPPs; the Association of Municipalities of Ontario (AMO); the Federation of Canadian Municipalities (FCM); Mayors and Regional Chairs of Ontario (MARCO); Ontario's Big City Mayors (OBCM); and the Ontario and Canadian Associations of Chiefs of Police, Niagara Regional Police Service (NRPS) and RCMP.

The following resolution, adopted by City Council at its meeting held on November 3, 2025, is forwarded for your consideration.

Whereas municipalities across Ontario are required to maintain a police service; and

Whereas municipalities across Ontario are required to constitute a municipal board to have policing responsibility for the municipality, or enter into a written agreement for an alternate provision of policing services; and

Whereas the City of Peterborough has constituted a municipal board; and

Whereas municipalities, across Ontario, with a police service board, are required to “ensure adequate and effective policing is provided in the area for which they have policing responsibility in accordance with the needs of the population in the area and having regard for the diversity of the population in the area” and

Whereas police service boards within municipalities where court proceedings are conducted are required to ensure the security of judges, other judicial officials, members of the public participating in court proceedings, ensuring the secure

custody of persons in custody who are on or about the premises, including persons taken into custody at proceedings; and

Whereas the provision of court security is not part of providing adequate and effective policing; and

Whereas the cost of providing court security is a cost of the municipality, regardless of whether all matters originate within that municipality; and

Whereas municipalities across Ontario are required to have and maintain critical infrastructure, including appropriate police facilities and equipment, to ensure adequate and effective policing is provided; and

Council request that the Province of Ontario provide targeted financial assistance to municipalities to offset any additional costs that are directly and demonstrably incurred as a result of compliance with the Community Safety and Policing Act, 2019, and not general increases to police budgets; and

Therefore, be it further resolved that:

Council urge the Province of Ontario to review and reform its current police grant programs to ensure a more equitable distribution of funding to municipalities so that communities with growing populations and expanding service demands receive fair and sustainable provincial support; and

Therefore, be it further resolved that:

Council request that the Province of Ontario provide stable sustainable funding to offset costs associated with the provision of providing court security services; and

The following resolution was passed by Ajax Town Council at its meeting held on November 17, 2025:

Whereas, we are approaching the cold winter months and the number of people experiencing homelessness in Ajax and Durham Region continues to rise drastically, with more than 1,000 people on Durham Region's by-name list as of August, including specifically 200 people in Ajax seeking support to change their housing status¹; and

Whereas, in September 2024, Ajax Council passed a motion to support Ontario Big City Mayors (OBCM) SolveTheCrisis.ca² campaign requesting that the provincial and federal governments take immediate action to solve the homelessness and mental health crisis gripping our communities; and

Whereas, while the provincial government has provided support for new programs such as Homeless and Addiction Recovery Treatment Hubs (HART Hubs), it does not adequately address the growing crisis and the financial and social impact on municipalities and regions; and

Whereas, according to the Association of Municipalities of Ontario, municipalities are providing [51.5% of the total reported homelessness program funding across all three levels of government](#), making a significant financial impact on municipal budgets³; and

Whereas, OBCM recently passed a motion at their October Meeting re-iterating the need for provincial support in addressing this crisis by allocating more funding to programs that address chronic homelessness; and

Therefore, be it resolved:

1. That Ajax Council reconfirms their support of the Solve the Crisis Campaign and calls on Ajax residents to join us in appealing to the provincial and federal governments for support by visiting SolveTheCrisis.ca; and
2. That Ajax Council asks that the provincial government to take action on the requests of the Solve the Crisis Campaign that have not been fully addressed including:
 - a. Appoint a responsible ministry and Minister with the appropriate funding and powers as a single point of contact to address the full spectrum of housing needs as well as mental health, addictions and wrap around supports.
 - b. This single Minister must strike a task force with sector representatives including municipalities, health care leaders, first responders, community services, the business community, and the tourism industry to develop an Ontario Action Plan.
 - c. Provide municipalities with the tools and resources to transition those in encampments to more appropriate supports, when deemed necessary.
 - d. Commit to funding the services our unhoused population needs, community by community, to fill in gaps in the system.
 - e. Invest in 24/7 community hubs or crisis centres to relieve pressure on emergency departments and first responders; and
3. That Ajax Council asks that the provincial government prepares a 2025/2026 winter homelessness response plan to help municipalities ensure that we can keep our unsheltered residents who are sleeping outdoors with the services they need to keep them safe in colder weather; and
4. That a copy of this resolution be sent to Doug Ford, Premier of Ontario, Rob Cerjanec, MPP for Ajax, local MPPs across the Region of Durham, Durham Regional Council, all Ontario Municipalities, Ontario Big City Mayors (OBCM).



Dear Mr. Mayor:

Thank you for your correspondence of November 20, 2025, outlining proposed measures to protect vulnerable Canadian citizens.

I have taken note of your proposals and acknowledge their importance. I would highlight that the legislative authority governing both bail and criminal sentencing in Canada falls under the purview of my colleague the Honourable Sean Fraser, Minister of Justice and Attorney General of Canada and Minister responsible for the Atlantic Canada Opportunities Agency. I have therefore taken the liberty of forwarding him a copy of your correspondence for his information and consideration.

I believe it is critical that Canadians have confidence in their criminal justice system. I can assure you that the Government of Canada is firmly committed to delivering public safety results for Canadians, including combatting repeat and violent sexual crime. As both Secretary of State (Combatting Crime) and as Member of Parliament for Brampton North—Caledon, I share this commitment.

I would like to highlight the recent introduction of Bill C-14, referred to as the *Bail and Sentencing Reform Act*, which was tabled in the House of Commons in October 2025. Bill C-14 introduces a series of targeted measures that aim to make bail laws stricter and sentencing laws tougher for repeat and violent offenders, including sexual offenders, support the front lines, and invest in long-term crime prevention. In addition, the introduction of Bill C-16, the *Protecting Victims Act*, on December 9, 2025, represents one of the most significant updates to Canada's Criminal Code in decades. This legislation is designed to confront emerging threats and provide stronger protections for victims and survivors, reinforcing our shared goal of a safer and more resilient society.

In the case of individuals convicted of sex offences, we are ensuring that effective measures are in place to protect communities. As you are aware, one of these measures is the National Sex Offender Registry (NSOR), which was established under the *Sex Offenders Information Registration Act* (SOIRA) in 2004.

Under SOIRA, registered sex offenders have a legal obligation to report information to the police, including their names, contact information, physical description, address of residence, vehicle information, as well as their place of employment, volunteer activities, and the type of work they do. This information helps police prevent and investigate crimes of a sexual nature by providing up-to-date information relating to convicted sex offenders. Offenders who do not comply with reporting obligations under SOIRA are subject to penalties under the *Criminal Code*.

In addition, mechanisms are also in place to notify the public when a high-risk offender returns to their community. When a high-risk offender is about to be released from custody, the Correctional Service of Canada (CSC) advises local police and provides detailed information to law enforcement about that individual. The CSC provides police with a comprehensive information package on Federal offenders who potentially pose a threat to any person and are being released after completing their entire sentence.

To ensure the public is aware of high-risk offenders in the community, most Provinces and Territories have legislation or policies in place to issue public notifications regarding these individuals, and the majority of local police across Canada publicize information about any released offenders where they consider there to be a heightened risk to the public.

Furthermore, in December 2024, the Government of Canada brought into force the *High Risk Child Sex Offender Database Act* (HRCsODA). The HRCsODA requires the Commissioner of the Royal Canadian Mounted Police to create a publicly accessible database of high-risk child sex offenders in Canada. Once the database is operational, it will offer a new resource for the public to contribute to their own safety based on verified information.

Ultimately, the effectiveness of these legislative changes relies on continued collaboration with our provincial, territorial and municipal partners, particularly in managing and resourcing key areas of the justice system under their jurisdiction including policing, prosecutions, bail processes, courts and victim services.

Crime prevention is a key pillar of community safety, reducing victimization, and strengthening social cohesion. Public Safety Canada's (PS) approach to crime prevention is to address the underlying conditions that produce crime, to help disrupt the cycle of criminal behavior and repeat offending. Through PS' National Crime Prevention Strategy (NCPS), the Government of Canada currently invests over \$47 million annually in community-based crime prevention efforts that target youth. Recognizing the value of local knowledge, PS supports locally-led initiatives by working with communities to implement projects that reflect their unique safety needs and priorities.

Funding under the NCPS is used to reduce risk factors and build protective factors among vulnerable youth; prevent youth violence; and foster crime prevention in Northern and Indigenous communities. The focus of the NCPS is on influencing the behaviours that can increase the likelihood of criminality, effectively working to address all types of crime. Accordingly, the NCPS focuses on children, youth, and young adults between the ages of 6 to 30.

My colleagues the Honourable Gary Anandasangaree, Minister of Public Safety, the Honourable Sean Fraser, Minister of Justice and Attorney General of Canada and Minister responsible for the Atlantic Canada Opportunities Agency, and myself, will continue to engage with our partners and stakeholders to support public safety. We welcome continued dialogue with you and your council as we advance these reforms together.

Protecting Canadians is a Government of Canada priority and we will continue to pursue sound policies and investments that are proven to prevent crime and victimization, and keep our communities and citizens safe.

Thank you again for writing and for your service to your community.




At the January 5, 2026, Regular Council meeting for the Town of Saugeen Shores, the following motion was passed:

Resolution 010-2026

Whereas the Saugeen Valley Conservation Authority “The Authority” was established in 1950, 75 years ago by a group of municipalities, as a response to problems associated with flooding; and

Whereas the Town of Saugeen Shores is the single largest member by apportionment in this collection of 8 member municipalities, comprising of the main channel and mouth of the Saugeen River at Southampton. The Town of Saugeen Shores is the largest contributor of annual levies that cover the operation of the Authority; and

Whereas the member municipalities cover 44% of the operational costs of the SVCA, 7% coming from the Provincial funding and the remaining is generated through internally generated revenue and permitting fees; and

Whereas the fees charged by Conservation Authorities have been frozen for 3 years which has had the effect of shifting the financial burden onto levies and by extension the property tax payers; and

Whereas the Provincial Conservation Authorities Association (Conservation Ontario) has and continues to provide the respective Authorities with guidance, oversight, and consistency of regulation application; and

Whereas the development of the “Agency” is proposed to be funded by municipalities and serves only to add another layer of Government bureaucracy, which by definition will serve only to increase financial burden on member Municipalities; and

Whereas one of the stated objectives of the “Agency” is development of a single digital permitting platform. This approach will serve to alienate a significant portion of our residents who do not have access to internet services, due to rural location or due to religious beliefs; and

Whereas the SVCA is located in a primarily rural geographic region, that due to the proposed consolidation of 7 Authorities will be seemingly overshadowed by much larger and more densely populated authorities with much larger urban components; and

Whereas the SVCA has worked hard to achieve a streamlined and efficient operation and service delivery model, due in large part to the direct oversight by a Board comprised of member municipalities appointed elected officials; and

Whereas the proposed consolidated Huron-Superior Authority would be comprised of up to 80 municipalities, 23,000 sq/km and by extension, a Board of Directors that would be so large as to be unmanageable, and would surely result in smaller rural municipalities losing direct control over the operation of the Authority; and

Whereas the inclusion of Lakehead Region CA in North West Ontario, could have detrimental repercussions arising from travel distance and geographic differences alone; and

Whereas the Saugeen Valley Conservation Authority owns and manages thousands of acres of CA land, many of which are income generating, through user fees, land leases, managed forest harvest, and campground fees. The Amalgamation plan does not address how these assets, which by extension belong to member Municipalities, would be equitably divested. Many of these properties were granted to the Authority, specifically detailing the nature and terms of ownership which legally must be maintained going forward; and

Whereas Authorities across the province have liquid assets in the form of trusts, and reserves that belong to member municipalities which run the risk of being swallowed up by large Authorities with larger budgets and resources.

Now Therefore, be it Resolved that the Town of Saugeen Shores requests that the Amalgamation into the “Huron Superior Regional Conservation Authority” as outlined in ERO 025-1257 be reconsidered. This in order to maintain the local oversight and protect against as yet unforeseen consequences which will serve to undermine the SVCA’s ability to provide regional knowledge-based service delivery and management of properties under our stewardship and ownership; and

Further ensure that should the amalgamations go forward that consideration be given to grouping Rural Authorities with similar watershed characteristics together, while grouping more Urban Authorities together for similar reasons; and

Further ensure that any transitional costs are fully funded by the Province and not borne by member Municipalities, and that Municipalities are provided with clear funding models in 2026 so as to allow for sufficient planning data for the 2027 budgets; and

Further that Saugeen Shores Council urges the Province to engage with affected municipalities and First Nations communities in a meaningful way to collaboratively review the service delivery model and standardize only where necessary paying attention to the different needs of Rural and Urban Authorities. That the Province use this approach rather than develop another level of administration and the associated financial burden that would surely result; and

Finally that this resolution be included in the Municipalities ERO response and be forwarded to the:

- Premier of Ontario;
- Minister of Environment Conservation and Parks;
- Bruce County Council;
- All of Ontario’s Municipalities;
- Huron Bruce MPP/ Minister of Rural Affairs;
- The board of Rural Ontario Municipal Association;
- AMO; and,
- Conservation Ontario.

To Mayors and Chairs of Police Service Boards in Strong Mayor Power Municipalities,

We are writing to provide information on the powers and roles of municipalities, mayors, and police service boards in establishing a police service board budget, particularly in municipalities with Strong Mayor Powers.

In a strong mayor municipality, the Head of Council has the responsibility to prepare and propose the municipal budget on or before February 1 of each year, which would be subject to a council amendment, head of council veto and council override process.

This municipal budget includes estimates of amounts required during the year, including any amounts required for boards, such as the police service boards budget established in accordance with the *Community Safety and Policing Act, 2019* (CSPA). **The Head of Council's strong mayor budget powers do not include the power to limit police service board budget increases or veto estimates submitted by police service boards.**

The CSPA provides the purposes for which the funding is to be provided to a police service board, establishes a process for submitting budget estimates, municipal approval of such a budget, and the mechanisms available to address disagreements.

Under section 50 of the CSPA, a police service board must submit their operating and capital estimates to the municipality, which is then responsible for establishing an overall budget for the police service board. **Although municipalities are not required to adopt the board's estimates as submitted, they cannot approve or reject specific line items within the estimates.** Municipalities are required to provide police service boards with sufficient funding to comply with the CSPA and its regulations, as well as pay the expenses of the board's operation, excluding remuneration for board members.

There are dispute resolution mechanisms established under the CSPA to address situations in which a police service board is not satisfied that the budget is sufficient to permit the board to comply with the legislation and pay for the board's operation.

The CSPA provides two dispute resolution pathways: the board and municipality may jointly apply to the Commission Chair of the Ontario Police Arbitration and Adjudication Commission (OPAAC) to appoint a conciliation officer, or the board may give the municipality written notice referring the matter to arbitration.

In arbitration, a municipality can argue, among other things, that costs could be reduced if the board entered an agreement to receive services from another police service. If the municipality can show that the board could reasonably have obtained policing services under an agreement (under section 14 of the CSPA, with another police service board or the Commissioner of the Ontario Provincial Police) at a lower cost while still meeting applicable standards, the arbitrator cannot deem the budget insufficient to the extent of the amount that could have been saved by entering into the agreement.

For example, if a police service board seeks funding for a \$15 million policing budget, and the municipality can demonstrate that equivalent services meeting all standards could have been provided through a budget at \$13 million, where some services are provided pursuant to an agreement with another police service, in this case, the arbitrator could not find the budget insufficient to the extent of the additional \$2 million.

Following arbitration, the municipality shall amend the board's budget to reflect the arbitrator's decision.

Re: Bill 68, Plan to Protect Ontario Act, and ERO Posting 025-1257

At the January 12, 2026, Regular meeting, Stratford City Council considered resolutions from the Upper Thames River Conservation Authority and the Long Point Region Conservation Authority regarding Bill 68 and ERO Posting 025-1257 relating to the proposed boundaries for the regional consolidation of Ontario's conservation authorities.

At the meeting, Stratford City Council adopted the following resolution:

R2026-21

THAT CA-2026-007, being resolutions regarding Bill 68: Plan to Protect Ontario Act, be endorsed.

A copy of the endorsed resolution has been provided below:

WHEREAS the Conservation Authorities Act (1946) enables municipalities to establish local conservation authorities, and when municipalities choose to form such authorities, they assume responsibility for governance and funding through the appointment of a Board of Directors and the provision of an annual levy to cover expenses;

AND WHEREAS the City of Stratford established the Upper Thames River Conservation Authority (initially formed in 1947);

AND WHEREAS local municipalities currently provide approximately 35% of total conservation authority funding, while the Province of Ontario provides approximately 2% (2026 budget);

AND WHEREAS municipalities have governed their respective conservation authorities for decades, tailoring programs and services to local watershed needs, maintaining accountable service standards, and ensuring fair and predictable costs for ratepayers;

AND WHEREAS conservation authorities collectively own and manage thousands of acres of land. Many of these properties were entrusted to the UTRCA for long-term protection, stewardship, and the public good, with the expectation that such lands would be cared for by locally governed conservation authorities;

AND WHEREAS Bill 68 (Schedule 3) proposes the creation of the Ontario Provincial Conservation Agency, a Crown corporation that would assume governance responsibilities and consolidate Ontario's 36 conservation authorities into seven regional authorities, with municipal cost apportionment yet to be defined;

AND WHEREAS the Province already possesses the authority to establish overarching legislation, regulations, and standards through the Conservation Authorities Act and the Ministry of the Environment, Conservation and Parks;

NOW THEREFORE BE IT RESOLVED THAT the Council of The Corporation of the City of Stratford calls on the Government of Ontario to maintain local, independent, municipally governed, watershed-based conservation authorities to ensure strong local representation in decisions related to municipal levies, community-focused service delivery, and the protection and management of conservation lands;

AND FURTHER THAT while the City of Stratford supports provincial goals for consistent permit approval processes, shared services, and digital modernization, imposing a new top-down agency structure without strong local accountability and governance risks creating unnecessary cost, red tape, and bureaucracy, thereby undermining efficiency and responsiveness to local community needs;

AND FURTHER THAT the City of Stratford supports efforts to balance expertise, capacity, and program delivery across the province, and requests that the Province work collaboratively with municipalities and local conservation authorities to determine the most effective level of strategic consolidation to achieve both provincial and local objectives;

AND WHEREAS better decisions are made when democracy is respectful and constructive and the voices of diverse genders, identities, ethnicities, races, sexual orientation, ages and abilities are heard and represented around municipal council tables;

AND WHEREAS the Association of Municipalities of Ontario's Healthy Democracy Project has identified concerning trends with fewer people voting in local elections and running for municipal office;

AND WHEREAS in 2024, female elected representatives from across Halton formed a group called H.E.R. (Halton Elected Representatives) which pledged to speak out against harassment and negativity in politics and call on elected officials to uphold the highest standards of conduct;

AND WHEREAS H.E.R. Halton has launched a campaign called *Elect Respect* to promote the importance of healthy democracy and safe, inclusive, respectful work environments for all elected officials that encourages individuals to participate in the political process;

AND WHEREAS on June 5, 2025, the Canadian Association of Feminist Parliamentarians launched a non-partisan "Parliamentary Civility Pledge" to encourage all parliamentarians to commit to end workplace harassment and increase civility on Parliament Hill, modelled after the pledge developed in Halton by representatives of H.E.R.

NOW THEREFORE BE IT RESOLVED:

THAT the Township of Larder Lake Council supports the *Elect Respect* pledge and commits to:

- Treat others with respect in all spaces—public, private, and online,
- Reject and call out harassment, abuse, and personal attacks,
- Focus debate on ideas and policies, not personal attacks,
- Help build a supportive culture where people of all backgrounds feel safe to run for and hold office,
- Call on relevant authorities to ensure the protection of elected officials who face abuse or threats, and
- Model integrity and respect by holding one another to the highest standards of conduct.

AND THAT the Township of Larder Lake Council calls on elected officials, organizations and community members to support the *Elect Respect* campaign and sign the online pledge at www.electrespect.ca.

AND THAT a copy of this resolution be sent to the Association of Municipalities of Ontario, Ontario's Big City Mayors, the Federation of Canadian Municipalities, the Office of the Mayor of Burlington, relevant MPs and MPPs, Regional Police, the Ontario Provincial Police and the Royal Canadian Mounted Police.
