Please read this information before submitting your application for a Snow Clearing Exemption Permit

- Please allow 1 – 2 weeks for processing. Permits will not be issued at time of application.
- Snow Clearing Exemption Permit is only valid for the location listed on the front of the permit.
- Proof of residency and proof that all vehicles are registered to their address is required at the time of application. All documents must contain your name and correct address. If neither shows your correct address, you must present a lease agreement, current utility bill or purchase/ sale agreement prior to the permit being issued. For multiple tenant situations, please provide a letter from the landlord indicating the number of tenants and number of vehicles parking at the property. Letter to be provided at the time of application.
- Permits are valid for 1 year from date of purchase.
- Permit holders must continue to obey all general parking by-laws:
 - Vehicles cannot park within 10m of an intersection
 - Vehicles cannot park within 1.5m of a driveway
 - Vehicles cannot park longer than 12 hours on any highway
 - Vehicles cannot park within 3m of a fire hydrant(for a full list of parking violations please review the Traffic & Parking By-law 89-2000)
- Permit shall be affixed to the rear view mirror or placed on the drivers side dashboard.
- All permit applications are subject to review and approval by City Staff.
- A Snow Clearing Exemption Permit does not guarantee a parking space.
- The City reserves the right to cancel a permit at any time for improper use of the permit.
- The City reserves the right to remove any vehicle from the highway that becomes a safety concern during snow clearing operations.

Why do you need to park on the road?
